PAHL'S FARM UPDATE

CHAI informed us in December that they will be selling the Pahl's Farm property because it is not feasible to proceed with their plans for lowincome housing. The property has been put up for sale "as is" for the conforming market priced 22 townhouses. With housing prices increasing in our community, this parcel of land could be appealing for developers. Nevertheless, VNCA is requesting that the county work with VNCA and Neighborsspacebaltimorecounty.org to preserve and enhance this parcel of land for the benefit and use of the area communities. This will be very challenging project because the cost of the Pahl's Farm parcel will be at least \$500,000 and funding has been significantly reduced on all levels of government as a result of the pandemic. However, we have submitted requests to the county to see what can be done to keep this as open space community property with enhancements that improve the environment and maintain the ecological balance in the area. We need your support!

- Visibility deters those with bad intentions
- Helps to keep our community crime free
- Meet neighbors/develop a sense of community
- Easy to do patrol as you walk, run, cycle, drive
- Call 911 if you see anything suspicious
- Pick-up magnetic signs at 4123 Bedford RD (driveway bin)

- There are over 365 households in Villa Nova; if each household picked a day to patrol, we could cover the entire year with one of the best crime prevention tools.



iWatch Baltimore County is a neighborhood awareness program encouraging citizens to be vigilant in identifying and reporting suspicious behaviors. Submit suspicious activity through the iWatch Baltimore County tip form or email your tip to iwatch@baltimorecountymd.gov.

Suspicious Behaviors to Report:

- Unknown individuals loitering or lurking
- People drawing or measuring important buildings
- Strangers asking questions about a home/building
- Abandoned backpack, package, briefcase or suitcase
- Vehicles left or abandoned in No Parking zones
- Intruders in secure areas
- Unusual chemical smells or fumes
- Someone purchasing supplies or equipment that can be used to make bombs or weapons
- Someone purchasing uniforms without having the proper credentials
- People who identify themselves but do not have credentials

Research has shown that communities with active Citizens on Patrol are safer. COP is a separate/ different organization from the Villa Nova Community Association. COP is focused on crime and works closely with the county police department as a citizen's watch function, not policing or enforcement function. Villa Nova is served by the Precinct 4, Pikesville, 410.887.1279, Community Outreach 410.887.6775. The first Tuesday in August. VNCOP hosts a National Night Out event featuring a Q & A with the BCoPD and residents receive crime prevention materials please consider signing up for a patrol once a month to help keep our community safe. You may patrol while driving or walking. Car top and magnetic car door signs as well as patrol vests for walkers are available. Donations are always appreciated.

BALTIMORE COUNTY NEWS FREE! FREE! TREES! TREES! TREES!

The county's Department of Environmental Protection and Sustainability (EPS) is working with residents, landowners and communities in Baltimore Co. to increase our tree canopy and help our environment through free tree planting programs. Planting trees is one of the single best things we can do to protect the environment and beautify our communities as they clean the air and water, capture carbon from the atmosphere, reduce erosion, provide habitat for birds and other wildlife, increase property values, etc. There are no costs for the tree plantings. These programs help the County meet tree-planting goals and requirements. Native tree species are carefully selected by EPS for factors such as ecosystem functions, mature size, native range, safety and aesthetics. We have lost a significant number of trees in Villa Nova and all residents are asked to consider adding at least one tree to their property to help restore Villa Nova to the unique woodland beauty for which it is known. Let us all work together on this project. ALERT REPORT SCAM

ALERT MDOT MVA SCAM

If you received a text from "Maryland-MDot Urgent" DO NOT CLICK ON THE LINK - DELETE IT! It was not sent by MDOT or MVA.

MORTGAGE SCAM

The Office of the Attorney General states scammers are calling mortgage company customers, claiming to be representatives of that company, and offering the customer a loan modification or asking the customer to make "trial" payments to them using a debit card, money order, or gift card (major red flag—no legitimate company will ask you to buy gift cards to make payments).

If you have divulged personal or financial information to someone who called you, and suspect they may have been trying to scam you, call or email the Identity Theft Unit at 410-576-6491 or idtheft@oag.state.md.us to learn how to protect your identity and financial information.

BALTIMORE COUNTY CODE ENFORCEMENT

The following are some code enforcement issues that should not exist on private residential property and will be reported to code enforcement.

Unsanitary or unsafe conditions - Grass and vegetation should not be higher than 2 feet in front, side and back yards. Shrubbery that faces that street, regardless of the height, should be kept neatly trimmed. All grass, vegetation, shrubbery, etc. on residential property within the 3 feet from the road must be kept cut and clear; this is a safety issue as three feet is the sight line for drivers.

Rubbish/garbage not stored in trash receptacles - Trash cans must have lids. Trash receptacles should be set out and taken in no more than 24 hours of pickup day.

Unsound structural exterior - Defective roof, steps, chimney, window, doors and fences

Inoperable vehicle or private property - Cars, trucks and trailers with or without a current registration, (i.e., tags) should not be kept on lawns, back yards, side yards, or driveways.

Fallen trees - Trees that have been cut down or have fallen down must be cleared and removed. Branches, limbs etc. can be picked up on trash collection days (check schedule); they must be cut and no longer that 3 feet and 3 inches in diameter.
