

BEWARE the Emerald Ash Borer

Villa Nova is full of ash trees. The emerald ash borer (EAB) is a green jewel beetle that infests and feeds on the ash species including green ash, black ash, white ash, and blue ash causing considerable damage. Damage occurs in infested trees due to larval feeding.

Adult beetles are typically bright metallic green and about 0.33 in long. A female can live around six weeks or longer and lay up to 200 eggs. Eggs are deposited between bark crevices, flakes, or cracks and hatch about two weeks later. After hatching, larvae chew through the bark

disrupting the flow of nutrients and water thus killing the tree.

Ash trees are primarily treated by direct injection of insecticides into the tree or soil drench. Some insecticides cannot be applied by homeowners and must be applied by licensed applicators. Initially, tree injections will not compromise tree health, but over many years drilling and chemical wounds will compromise the tree's health. Damage from EAB can continue to increase over time even with insecticide applications. Please contact a pest control specialist.

ZONING BATTLE – VNCA WORKING FOR YOU!

Last year, an assisted living facility installed a large (6 feet by 4 feet) sign on the front lawn of their property. This large type enterprise or business sign is not allowed in a strictly residential area such as Villa Nova. VNCA had to request the removal of the sign because if the sign was allowed to stay, because of precedence and practice, other home businesses in Villa Nova would also be allowed to install similar large signs. We knew that the installation of these signs would detract from the attractiveness of the community and possibly decrease the property values. However, this violation came at a significant cost to the VNCA. Because of irregularities in the zoning application and the zoning

departments handling of this case, it required that VNCA hire a lawyer. This case took over a year, however, VNCA did prevail and the sign is to be removed. This is part of the work that the volunteers of the VNCA do to maintain, enhance, and improve the entire community. In order for VNCA to be prepared to act in these types of situations, it is imperative to rebuild our resources. We are requesting that every household pay the \$15 annual dues. Your dues are tax deductible because VNCA is a 501c3 non-profit incorporated organization; also, any additional amount donated above the \$15 dues is also tax deductable. Please don't delay, but handle it today!

WATER BILLS TO RISE 12%, 8% FOR NEXT 2 YEARS

An average family of four in Baltimore County will pay an additional \$227.43 on their water and sewer bills over the next two years starting July 1. The increases follow a 15 percent rate hike that took effect last July. The money is needed to replace water pipes, reline sewer pipes and address other portions of the aging infrastructure. Water rates will rise about 12 percent effective July 1 and an additional 8 percent July 1, 2017. The public water system, called the Metropolitan District, is an extension of the Baltimore City system, which draws water from county reservoirs, treats the water, and then returns it to county residents at cost. The system is required to be financially self- supporting.

COUNTY, HUD REACH SETTLEMENT ON HOUSING DISCRIMINATION PRACTICES thus settling a 2011 complaint filed against the county by the Baltimore County Branch of the NAACP, Baltimore Neighborhoods, Inc., and three individuals alleging decades of unfair housing practices. The complaint claimed that the county created affordable housing in areas concentrated by mostly poor Blacks, focused new housing on seniors and failed to pro-

vide adequate housing for people with disabilities. By the county's own analysis conducted in 2012, it had the most segregated neighborhoods in Maryland. The terms of the agreement also require the county to establish a housing mobility program and provide 2,000 Housing Choice Vouchers over the next 12 years to assist families with access to better quality jobs and schools.

HIGHLIGHTS OF HOUSING SETTLEMENT

Baltimore County will:

- invest \$3 million annually for 10 years to create 1,000 affordable housing units
 - at least 500 of the units will have three or more bedrooms to accommodate families with children
 - at least one-third of the units will be accessible and made available to people with disabilities
 - ensure all of units comply with the accessibility requirements of the fair Housing act
 - provide Housing Choice vouchers to at least 2,000 families
 - proactively market the units to po- tential tenants who are least likely to apply, including African American families and families with a member who has a disability.
- provide an additional \$300,000 annually for 10 years to finance structural modifications to make other affordable housing units in Baltimore County accessible
- Run a housing mobility counseling pro- gram to offer expanded housing opportunities to families.
- Seek the enactment of legislation that prohibits discrimination based on source of income
- pay the three individual claimants \$150,000 in monetary relief.
